

**STAINBOROUGH PARISH COUNCIL**  
**Minutes of the Parish Council Meeting held on 13<sup>th</sup> October 2016**  
**At Hood Green Pavilion commencing 7.00 p.m.**

**1278. Apologies for Absence:** There were no apologies for absence.

**1279. To receive disclosures from Councillors on matters to be considered at the meeting:** No disclosures of personal and prejudicial interests were declared

**1280. To approve the minutes of the Council Meeting held on 18<sup>th</sup> August 2016:** The minutes of the meeting held on 18<sup>th</sup> August 2016, having been previously circulated, were approved as a true record.

**1281. Matters arising:**

- a. Penistone Clean & Tidy Team:** Elaine Down outlined the type of work that the Penistone Clean & Tidy Team could do for the Parish Council. The team, with the help of a few local volunteers have already cut back the brambles adjacent to the Pavilion and planted wild flower seeds. They have also started to cut back the overgrown hedge at the back of the Pavilion. Brian Moss to provide Elaine or John Openshaw with any requests. The Team can also pick up green waste from jobs carried out by our own volunteers.
- b. Barnsley Bus Partnership Consultation:** Tenders have been requested by SYPTTE for the Bus Services now proposed through the Parish. Once these tenders have been returned approval will be sought from Sheffield City Region and Barnsley MBC. If approved the new timetables will be operational from January 2017.
- c. Pavilion – General Improvements:** There has been no further progress on Pavilion improvements. The gate to the Pavilion adjacent to the ramp is in poor condition and needs to be replaced. Brian Moss to obtain a quotation.
- d. Safety at Stainborough Crossroads:** Brian Moss will contact the Tankersley Clerk, Kenny Blanton to check on their progress with SDI's and to determine whether there are lessons to be learned from their project.  
Richard Elmhurst said that he is proposing to reduce the height of the wall from Stainborough Crossroads along Round Green Lane which he hopes will improve visibility at the junction. He is also proposing changes to the location of signage directing people to Round Green Deer Farm. Following a number of accidents at the bottom of Lowe lane where speeding cars have been unable to negotiate the bend the installation of arrow / direction markers was suggested. - e. Dog Fouling:** Brian Moss and Kelvin Taylor have fitted the majority of the new signs. Two are outstanding, one is to be fixed to a concrete fence post at the entrance to the recreation ground from Greno View. This is to be fixed directly to the column by Totty's. The last sign will be fitted to the new gate once this has been fitted.
