

STAINBOROUGH PARISH COUNCIL
Minutes of the Parish Council Meeting held on 18th August 2016
At Hood Green Pavilion commencing 7.00 p.m.

1270. Apologies for Absence: There were apologies for absence from Councillor Mrs. D Winder.

1271. To receive disclosures from Councillors on matters to be considered at the meeting: No disclosures of personal and prejudicial interests were declared

1272. To approve the minutes of the Council Meeting held on 7th July 2016: The minutes of the meeting held on 7th July 2016, having been previously circulated, were approved as a true record.

1273. Matters arising:

a. Barnsley Bus Partnership Consultation: Since the previous meeting representatives from the Parish Council have attended two meetings with SYPTE and members of local Parish Councils who were unhappy with the proposals made under the Barnsley Bus Partnership Consultation. At the first meeting the Parish Councils outlined the problems the proposals would pose for their parishioners and indicated the strength of feeling these proposals had raised.

The Parish Council decided to ensure that each household had a copy of the Barnsley Bus Partnership consultation paper and a letter explaining of the importance of responding to the consultation.

A second meeting with SYPTE and the Parish Councils was held at which they indicated that the results of their consultation had confirmed the feelings of the local residents and highlighted their needs.

SYPTE tabled a low cost solution which they could fund and they felt would be supported by BMBC. On examination the majority of local Parish Councils felt that although not ideal the SYPTE proposal provided an acceptable service and was a major improvement over the original offering. For Stainborough Parish Council the proposal was for a basic two hourly service from Barnsley to Penistone and return, covering a reduced day with additional trips at morning and afternoon peaks. A Sunday service was also proposed but this would depend on the tendered cost.

SYPTE will now obtain tenders for the new proposed routes before referring the new proposal to BMBC for approval. If approved the new routes would be in operation from January 2017

b. Pavilion – General Improvements: There has been no further progress on Pavilion improvements.

c. Safety at Stainborough Crossroads: Brian Moss will contact the Tankersley Clerk, Kenny Blanton to check on their progress and to determine whether there is any benefit to be gained from a joint project.

d. Dog Fouling: Brian Moss and Kelvin Taylor to arrange for fitting of new signs.

e. Village Planters: Brian Moss has chased up Elaine Downs who controls the Councils Green and Clean Team and she will ensure that the remaining brambles are cleared away and weed killer is applied to kill off the remaining vegetation.
