Minutes of the Parish Council Meeting held on 1st October 2020
At Hood Green Pavilion commencing 7.00 p.m.

1560. Apologies for Absence: No apologies were received for absence.

1561. New Councillor Mr. A Kirk: Kelvin welcomed Alan to the Parish Council

1563. To approve the minutes of the Council Meeting held on 13th August 2020: The minutes of the meeting held on 13^h August 2020, having been previously circulated, were approved as a true record.

1564. Matters arising:

- a. Pavilion – General Improvements:** Minor improvements to the playground are still required. Kelvin obtained a free bulk bag of bark chippings from Howarth Timber and these have been added to the slide surround. Further chippings may be needed once the level has settled
- b. Safety at Stainborough Crossroads:** The cost of Speed Indicators to be investigated to allow a full assessment of their suitability.
- c. Defibrillators:** MDB Engineering have fitted a smaller light over the Hood Green Defibrillator and this has made the cabinet more visible from the road at night. Training to be held in abeyance until the end of Covid19 restrictions.
- d. Volunteers:** Clearing of both West corners of recreation ground have been completed. All subsequent proposals will be scheduled for 2021.
- e. Hire of Pavilion:** The Pavilion is unsuitable for hire due to the Covid19 restrictions. Hand Towels and Sanitisers will be provided to improve facilities for Parish Council Meetings but the Pavilion will not be hired out for groups. Kelvin will source the Hand Towels and Sanitisers. Recommendations for future hire will be discussed in the New Year.
