Minutes of the Parish Council Meeting held on Thursday 22nd August 2024
At Hood Green Pavilion commencing 7.00 p.m.

2047 Apologies for Absence and Declarations of Interest on items on the agenda:

There were no apologies for absence.
No disclosures of personal and prejudicial interests were declared.

2048 Minutes of the Meetings held Thursday 27th June and Thursday 8th August 2024 : The minutes of the meeting of Stainborough Parish Council held on 27th June 2024, with small amendment to 2034, and of the Extraordinary meeting of 8th August 2024 having been previously circulated, were approved as a true record.

2049 Matters arising from the minutes not on the agenda

The meeting was opened to the public for the following 2 agenda items:

2050 Local Government Boundary Commission - Barnsley Boundary Review

The Clerk informed the meeting that, following the Extraordinary meeting and the production and delivery of the flyer, 34 residents had notified the Parish Council that they had sent correspondence to the Local Government Boundary Commission (LGBC) objecting to the proposals of Barnsley Council with regard to the current review. The Parish Council will be sending an e-mail objecting to the proposals to the Boundary Commission following this meeting.

Concern was expressed at the lack of time allowed for response, due to late submission of the new proposals from BMBC to the Boundary Review. The new proposals were BMBC's second proposal, the original one was not accepted by the Local Government Boundary Commission.

A resident noted that it appears that the electoral numbers for Penistone East were approximately the same as Dodworth and Tankersley together, without adding Stainborough Parish.

There was continuing concern that Stainborough Parish would be moved out of a Ward consisting of other small parishes into a Ward with 2 much larger areas. It was felt that Stainborough was just being used to join the other areas of the proposed new Ward.

The LGBC will publish its decision on **3rd December 2024**.

2052 Pavilion and Recreation Ground:

There was an issue with baskets in Stainborough. The Clerk negotiated an agreed option for the Stainborough hanging baskets for Autumn, Spring and Summer 2025. **Resolved:** action approved

2055 (i) Roads/ Highways Issues

- The Clerk noted that the cycle race, The Tour of Britian, was coming through the Parish on 5th September and there would be signage and short road closures during the day.
- It was requested that the temporary Speed Indicator Device be situated in Hood Green again and on Round Green Lane. **Resolved:** request installation in both locations.
- The Clerk previously gave an update on the reply from BMBC Highways regarding the speed limits in Stainborough, especially the Round Green area. Ward Cllr Burnett will request speed data for the village showing the 85% speed of vehicles.
- Information of road closure will be displayed on noticeboards and website.

(ii) Footpaths and Rights of Way Issues

It was noted that the bridleway from Lower Stainborough Fold to Baggerwood Road was overgrown and too narrow to use. **Resolved:** Report to BMBC
