# 2100 Local Government Boundary Commission - Barnsley Boundary Review

Following the LGBC published decision on 3<sup>rd</sup> December 2024, possible actions were discussed.

**Resolved**: the Clerk to contact Barnsley Metropolitan Borough Council to note the concerns of the Parish Council with regard to the consultation process. It was also noted that Ward Councillor Alex Bennett would be holding surgeries locally and the Parish Council also requested, during the on-line meeting with her Assistant, that Marie Tidball MP could hold a surgery in Stainborough. This may be in the latter part of the year.

## 2101 Pavilion and Recreation Ground:

**Bookings** – Ward Cllr Burnett is to hold a surgery in the Pavilion on 6<sup>th</sup> March 2025.

## Use of the Recreation Ground - Hood Green Pocket Park

Following the meeting with Silkstone Common Sports & Recreation Association at the December meeting to discuss the potential use of the Hood Green Pocket Park Football Pitch for junior football matches, issues around the use of the recreation ground were discussed, including parking issues, noise and potential disruption, maintenance of the football pitch and surrounding grassed areas, and repairs from usage.

Resolved: Use of the Recreation Ground would be approved for a trial period, for a suggested fee of £20 per game for the pitch only, a booking form will be produced and if the pavilion is required that would be at an
